WHAT YOU NEED TO KNOW ABOUT OVERDRAFTS AND OVERDRAFT FEES

An <u>overdraft</u> occurs when you do not have enough money in your account to cover a transaction, but we pay it anyway. We can cover your overdrafts in two different ways:

- 1. We have standard overdraft practices that come with your account.
- 2. We also offer <u>overdraft protection plans</u>, such as a link to another account, which may be less costly than our standard overdraft practices. To learn more, ask us about these plans.

This notice explains our standard overdraft practices.

➤ What are the <u>standard overdraft practices</u> that come with my account?

We do authorize and pay overdrafts for the following types of transactions:

- Checks and other transactions made using your checking account number
- Automatic bill payments

We will not authorize and pay overdrafts for the following types of transactions without your consent.

- ATM transactions
- Everyday debit card transactions

We pay overdrafts at our discretion, which means we <u>do not guarantee</u> that we will always authorize and pay any type of transaction. If we do <u>not</u> authorize and pay an overdraft, your **transaction will be declined**.

> What fees will I be charged if Denison State Bank pays my overdraft?

Under our standard overdraft practices:

- We will charge you a fee of up to \$25 each time we pay an overdraft item if your account is overdrawn more than \$10
- We will not charge you a fee if your account is overdrawn by \$10 or less on any given day
- If your account balance remains overdrawn for longer than 7 business days, we will charge your account a
 daily Negative Balance Fee of \$3 for each of the consecutive business days the account remains overdrawn,
 beginning with day 8. The Negative Balance Fee will be limited to 15 continuous charges while in a negative
 status, which may extend from one statement cycle to the next.
- There is a limit of \$150 per day on the total fees we can charge you for overdrawing your account

> What if I want Denison State Bank to authorize and pay overdrafts on my ATM and everyday debit card transactions?
